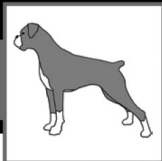

Under the Kennel name of Rivervale, together with a friend, I imported our first two Shar Pei into South Africa in 1989/90 from Macau and Hong Kong. We started the Shar Pei Club in South Africa in 1990, eventually bringing this club under the Kennel Union of South Africa banner in 1994. Subsequently, since 1999, I have bred and shown Shiba Inu – making a number of these dogs up into Champions.

I started my judging career in 1994 and since then have qualified through all the 10 FCI groups. I enjoy judging Junior Showmanship as well.

I have judged throughout South Africa and since 2011, Ireland on two occasions, Australia (Perth & Canberra), New Zealand, India, Thailand, Hungary and Zimbabwe.

Other dog activities:

Currently, I serve as the Chairman on the Federal Council of the Kennel Union of South Africa and as a member of the Kennel Union of South Africa Breed Judges Education Council. I hold honorary positions on various clubs, including Shar Pei, Belgian Shepherds, Rottweilers, Boxers, Utility Breeds and various All Breed Clubs.

Other discipline activities:

I tracked with three of my Shiba and was instrumental in organising administratively the first FCI Agility CACIAG show in South Africa.

I retired from my business after 38 years in July 2019.
