

WELCOME FROM YOUR CHAIRMAN


Welcome to our Frenchie family from near and far. It's wonderful to have you all here today for our most special day of the year.

ACCESS

Access to this event will only be allowed through the BOTTOM GATE on CLARKSON Road.

An Access Control Point will be set up at the gate, which will be manned for the entire duration of the event.

ATTENDANCE

Arrivals and departures will be monitored and only 250 people will be allowed at the venue at any one time.

In the interest of limiting and maintaining attendance at fewer than 250 people at any one time, exhibitors are urged to leave the grounds as soon as possible after completion of their classes.

SAFETY

All persons attending this event must wear a reusable cloth or sponge face mask, or a disposable surgical mask at all times, except when running while handling a dog in competition. Face shields are not legal. Any person not wearing a mask will be requested to leave the venue.
