Order of Judging Pomeranians on the day: (there are 3 shows for Pomeranians) Pomeranians will be judged last at Jakaranda Kennel Club, first at VFDHR, Followed by the Pomeranian Club of Gauteng.

**Classes:** Baby Puppy (4-6months), Minor Puppy, Puppy, Junior, Graduate, SA Bred, Veteran, Open, Champion, Neuter Dog.

**Order of judging Classes**: Baby Puppy (4-6months), Minor Puppy (6-9months), Puppy (9-12months), Junior (12-18months), Graduate (18-24months), SA Bred (Dogs born in South Africa), Veteran (Over 7 years of age), Open, Champion, Neuter Dog (For dogs of any age that have been castrated for whatever reason).

Order of Judging for Best in Shows: Best Baby Puppy in Show, Best Puppy in Show, Best in Show, Best Junior in Show, Best Veteran in Show, Best Neuter Dog.

Baby Puppy and Neuter are not eligible for BOB, only for Best Baby Puppy and Best Neuter in Show.
