All exhibits must be on leads at all times unless otherwise instructed by a Judge. The mating of bitches within the precincts of the show is forbidden. No entries with RAF or TAF will be accepted. Bitches in season will be permitted to compete in Breed Classes only. The Committee reserves the right to appoint alternative judges at its discretion.
