### ALL GROUP FINALS WILL BE JUDGED IN THE GROUP RINGS

**ORDER OF JUDGING: Breed – BOB, BP, BJ, BV then Baby Puppy Classes & BBP.**

**Groups – BOB, BBP, BP, BJ, BV. BISs – BVIS, BJIS, BBPIS, BPIS, BIS.**

**PLEASE NOTE: BENCHING SET UP (includes ANYWHERE on the grounds) WILL BE ALLOWED FROM 2PM ON FRIDAY 22<sup>nd</sup> NOVEMBER, 2019.**

- Exhibits *will* be marked absent if called 3 times.
- Please note that unless stated to the contrary, all Breeds will be judged in alphabetical order as listed in Appendix A of Schedule 2 of the KUSA Constitution.
- NO REFUNDS for incorrect submission of entry fees for any errors whatsoever made by the Owner/Exhibitor. Breed entries received with no sex specified will be entered as a DOG and Breed entries received with no class specified will be entered in the OPEN Class. Entries only accepted on the current official KUSA Entry form.
- The Show Committee reserves the right to appoint alternative judges, re-allocate breeds and advise all exhibits entered, of an earlier judging time, should the appointed judges be unable to officiate or receive too large or too small an entry.
- Dogs travelling from a region infected with Rabies are required to have a valid inoculation certificate against Rabies.
- Bitches in season will be permitted for Breed Classes.
- Exhibitor numbers can be collected from the show office before the commencement of the show.
- Sufficient parking has been provided - no vehicles will be allowed within the designated show area. Unhitched trailers will be allowed to be pushed in. PARKING AT OWNERS RISK.
- All exhibitors, handlers & owners are advised that they and any exhibit entered in any event may be photographed for, by or on behalf of JCKC for the use and possible publication of such photograph by JCKC.
- The mating or whelping of bitches within the precincts of the shows is forbidden.
- No animal other than an exhibit entered for competition or exhibition shall be allowed on the grounds, with the exception of registered guide dogs.

## THE ROYAL CANIN/JCKC GRAND NATIONAL CHAMPION COMPETITION

Dogs which have been awarded KUSA (Breed) Grand Champion and/or Supreme Champions status, prior to the closing date of the Event, will be eligible for entry in this Competition.

### CONDITIONS OF ENTRY

- All entries must be submitted on a **separate, current KUSA entry form with proof of qualification provided** either in the form of confirmation email issued by the KUSA Office or copy of Grand/Supreme Champion Certificate awarded by the KUSA.
- Attendance at this Competition is at the sole expense of the owner/exhibitor.
- All exhibitors taking part in this Competition are required to wear their exhibit number.
- All exhibitors are required to dress in a manner befitting this prestigious Competition. Jeans, T-shirts, shorts and Takkies are not acceptable dress in the ring. Shoes must be worn.
- It is a condition of entry that competitors may not use their dogs for the advertising of any dog food products, for a period of 12 months following the Competition, without the prior permission of any Sponsor in writing.

### JUDGE(S) TO BE ANNOUNCED ON THE MORNING OF THE SHOW

- A JUDGE WILL JUDGE PRELIMINARY ROUND & SEMI-FINAL ROUND
- A JUDGE WILL JUDGE FINAL ROUND OF 8 DOGS, OF WHICH 4 WILL BE PLACED

- Preliminary Judging Rounds will take place in respective Group rings, in the following order Terriers, Hounds, Utility, Toys, Herding, Working and Gundog Groups @ 07h30 – four (4) unplaced exhibits will be chosen from each Group to go forward to the Semi-Final Round
- The Semi-Final Judging Round will take place prior to respective Bests in Show categories in the BIS Ring - eight (8) unplaced exhibits will be chosen to proceed to the Finals
- Final Judging Round will take place after respective Bests in Show categories in the BIS Ring, where 4 dogs will be placed.

- *Reserve JCKC Grand National Champion 2019*
- *1st Runner-Up JCKC Grand National Champion 2019*
- *2nd Runner-Up JCKC Grand National Champion 2019*
