* Only Members of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union.

RIGHT OF ADMISSION RESERVED PLEASE NOTE:

This is an un benched Show. Bitches in season will be admitted to the Show. No. R.A.F. or T.A.F. entries will be accepted an d entry forms will be sent back. The Committee reserves the right to appoint an alternate Judge should any of the Judges be unable to officiate.

Mating of bitches within the precincts of the show is not permitted. Conditions attracting immediate disqualification are set out in Regulations 7 and 31 of Schedule 3.
