This show/event will be held under the rules & regulations of the Kennel Union of Southern Africa

All dogs are to be kept on leash at all times. All exhibitors are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs.

Puppies under four (4) months are not eligible for competition. Bitches in season will be permitted in Breed. The mating of bitches within the precincts of the Show is forbidden. Camping will be permitted. Trailers may be brought onto the grounds but judging will not commence until all cars are removed. The committee reserves the right to cancel classes or replace the judge should the need arise. The committee reserves the right to withdraw judging contract. Any dog entered incorrectly will automatically be entered in the Open Class. No changes will be made at the Show. Exhibitor's numbers will not be posted - they are to be collected on the morning of the show. The onus is on you to check that your entries have been received. Conditions attracting immediate disqualification are set out in Reg. 4 of Schedule 4 and Reg. 31 of Schedule.
