ORDER OF JUDGING

In terms of Schedule3, Reg. 5.5.1 the order in which the Breed Classes, Best in Group classes and Best in

Show classes will be judged:

Breed Judging: All breed classes except Baby Puppy, followed by Best of Breed, Best Puppy, Best Junior, Best Veteran etc. Thereafter Baby Puppies judged together i.e., Dog and Bitch

Group Judging: Main Group, Puppy, Junior, Veteran followed by Baby Puppy

Best in Show Judging: Best Baby Puppy, Best In Show, Best Puppy, Best Junior & Best Veteran

This Show/Event will be held under the Rules & Regulations of the Kennel Union of Southern Africa

Only Member of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licenced by the Kennel Union.

All exhibitors/handlers are always personally responsible for the control of their dogs and shall be personally responsible for any claims which may be made in respect of injuries which may arise or be caused by their dogs.

The mating of bitches within the precincts of the Show is forbidden

Puppies under four (4) months are not eligible for competition

The committee reserves the right to appoint other judges

All dogs are always to be kept on leash at all times

Conditions attracting immediate disqualification are set out in Reg. 4 Of Schedule 4 and Reg. 31 of Schedule
