Group Judging order: BIG, BPIG, BJIG, BVIG, BSABIG, BBPIG, Finals Judging order: BBPIS, BSABIS, BPIS, BJIS, BVIS, BIS

ONLY MEMBERS OF THE KENNEL UNION SHALL BE ENTITLED TO ENTER DOGS IN THEIR REGISTERED OWNERSHIP IN ANY CHAMPIONSHIP DOG SHOW LICENCED BY THE KENNEL UNION.

This show will be held under the Rules and Regulations of the Kennel Union of Southern Africa.

All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs.

The Committee reserves the right to appoint alternative Judges should any of the above be unable to officiate.

The committee reserves the right to withdraw judging contracts and to combine groups should this be required Puppies under 4 months are not eligible for exhibition

The mating of bitches within the precincts of the Show is forbidden. Bitches in Season are permitted For exhibition only, all exhibits must be entered in at least one(1) Breed class

Please note also that dogs used by Child and Junior handlers in handling classes must be entered in a Breed class at the same show

Conditions attracting immediate disqualification are set out in Regulations 7 & 31 of Schedule 3
