Breed entries received with no sex will be entered as a dog and breed entries with no class specified will be entered in the open class.

Entries without payment will not be processed/mailed entries will be accepted only with simultaneous submission of proof of payment.

No late entries will be accepted.

Any incomplete or illegible entries or those unaccompanied by the correct fees will be returned to the exhibitor.

Postal Entries – entries postmarked on or prior of the closing date will be accepted provided they are received within 5 days after the closing date.

Bring hard copies of your entry and payment in case there is a query.

Exhibit numbers can be collected from the show office on the day of the show.

### GENERAL

Prizes - Rosettes on offer for BOB and group winners.

Award Certificates - RCC certificates will only be printed on request.

Ring Plans - will be published on various sites

Bitches in Season - are permitted in Breed only. The mating of bitches within the precincts of the show is forbidden.

Camping – Regret, no camping

Parking - only in the permitted spaces

Catering - will be available for the whole weekend.

Please note that by entering and attending this event and signing the KUSA Disclaimer, participants are agreeing to comply with any instructions issued by the COVID-19 Compliance Officers, and that the organisers have the right to request that any person leaves the venue at any time.

## ACCESS

Access to this event will only be allowed through entrance in Union Road. An Access Control Point will be set up at the gate, which will be manned for the entire duration of the event. On arrival at the Access Control Point, all attendees will be required to be wearing a mask; have their temperatures taken and insert the result on their Disclaimer; hand in a completed and signed Disclaimer form, after which they will be allowed access to the venue. NO access will be allowed without the above.

## ATTENDANCE

Only organisers and their helpers, as well as dog owners, handlers and their assistants may attend. SPECTATORS ARE NOT PERMITTED. Arrivals and departures will be monitored and only 250 people will be allowed at the venue at any one time. In the interest of limiting and maintaining attendance at fewer than 250 people at any one time, exhibitors are urged to leave the grounds as soon as possible after completion of their classes.

## SAFETY

All persons attending this event must wear a reusable cloth or sponge face mask, or a disposable surgical mask at all times, except when running while handling a dog in competition. Face shields are not legal. Any person not wearing a mask will be requested to leave the venue. All attendees must observe social distancing and, whenever feasible, maintain a distance of at least 1.5 metres between themselves and others with whom they do not live. Hand Sanitiser will be available at the Access Control Point as well as on all Judges' tables, at ring entrances and in the toilet areas. All rings/arenas will have separate entrances & exits and spacious, clearly demarcated marshalling areas. All exhibitor gazebos, tents and benching areas to be spaced at least 1.5m apart (and be a minimum of 1.5m away from the ringside). Exhibitors are responsible for regularly cleaning and sanitising their own equipment and areas.

All equipment and furniture used at the event, including tables, chairs and office equipment, will be sanitised by the organisers before and during the event. Exhibitor numbers and award certificates will be available for collection from office and social distancing must be observed while waiting to collect numbers and certificates.
