- No RAF/TAF entries will be accepted (this is Registrations applied for or Transfers applied for)
- The mating of bitches within the precincts of the Show is forbidden.
- Puppies under four (4) months are not eligible for competition.
- All dogs are to be kept on a leash at all times
- Conditions attracting immediate disqualification are set out in Reg. 4 of Schedule 3, Reg. 31.
- Bitches in Season are permitted.
- All exhibitors are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs".

COVID-19

KUSA appeals to attendees at all licensed events to keep up basic precautions whenever possible to prevent a surge of infections, including:

- **Wearing a mask that covers your nose and mouth**
