Entry Fees: R50 per dog per class if you bring 1 dog

Puppy (9-12 months), Junior (12-18 months), Graduate (18-24 months), SA Bred (all dogs bred in SA), Open, Champions, Veteran (7 years +)

Best in Show, Best Puppy, Best Baby Puppy, Best Junior, Best Veteran

COVID-19 Protocols & Procedures will be observed at this event.

A maximum of 2000 people will be allowed at the venue at any one time if held outdoors, or 1000 attendees if held indoors.

All persons attending this event must wear a reusable cloth or sponge face mask, or a disposable surgical mask, except when running while handling a dog in competition. Face shield only are not legal. Any person not wearing a mask will be requested to leave the venue.

All attendees must observe social distancing and, whenever feasible, maintain a distance of at least 1,5m between themselves and others with whom they don't cohabit.

Sanitiser will be available at the Organisers' Office, on all Judges tables, at ring entrances and in the toilet area.

Please not that by entering and/or attending this event, participants are agreeing to comply with any instructions issued by the COVID-19 Compliance Officers, and that the organisers have the right to request any person who refuses to comply with a request or instruction to leave the venue. Any person found to be non-compliant may also be liable for disciplinary action under Schedule 1 of the KUSA Constitution.

This show is held under the Rules and Regulations of the Kennel Union of Southern Africa. Puppies under 4 months are not eligible for exhibition. The Committee reserves the right to replace the judge if our appointed judge is unable to officiate.

No animal other than an exhibit entered for competition or exhibition shall be allowed on the grounds with the exception of registered guide dogs.

Bitches in season may only be shown in classes at all events and Exhibitors must exercise due consideration towards other exhibits.

All exhibitors/handlers are responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs.

The mating of bitches within the precincts of the show are forbidden. All dogs to be kept on leash at all times. Conditions attracting immediate disqualification are set out in Reg 4 of Schedule 4 and Reg 31 of Schedule 3
