Bitches in season are allowed to compete in Breed, Agility and Dog Jumping only. Qualifying cards must be produced prior to entering the ring.

The Club reserves the right to appoint alternate judges should any of the above be unable to officiate. No RAF or TAF dogs will be accepted. Any incomplete or illegible entries, or those unaccompanied by the correct fees, will be returned. Any dog entered incorrectly will automatically be entered in the Open Class. No changes will be made at the Show.

N.B. EXHIBITORS' NUMBERS ARE TO BE COLLECTED ON THE MORNING OF THE SHOW. THIS SHOW WILL BE HELD UNDER THE RULES AND REGULATIONS OF THE -
All Exhibitors/Handlers are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs.

Only Members of the Kennel Union shall be entitled to enter dogs in their registered ownership in any Championship Dog Show licensed by the Kennel Union.

Puppies under 4 months are not eligible for exhibition.

The mating of bitches within the precincts of the Show is forbidden.

Conditions attracting immediate disqualification are set out in Regulations 7 & 31 of Schedule 3.
