Rules and Special Notices	<ul style="list-style-type: none"> • This Show will be held under the rules and regulations of the Kennel Union Of South Africa. • All dogs to be kept on leash at all times. • All exhibitors are personally responsible for their dogs at all times and shall be personally liable for any claims which may be made in respect to injuries which may arise or be caused by their dogs. • Puppies under 4 months are not eligible for the competition. • Bitches in Season will be permitted but handlers are asked to have due consideration for other exhibitors. • The mating of bitches within the precincts of the show is forbidden. • The Committee reserves the right to appoint another judge if necessary. • Any dog entered incorrectly will automatically be entered in the Open Class. No changes will be made at the Show. • Please bring hard copies of your entries and proof of payment to the show in case of a query. i.e. no hard copy as proof – no entry. • No electronic entry will be accepted on the day. • Exhibitor’s numbers will not be posted – they are to be collected on the day of the show. The onus is on you to check that the entries have been received. • Conditions attracting immediate disqualification are set out in Regulation 4 of Schedule 4 and Regulation 31 of Schedule. • Right of admission is reserved. • There will be no catering at Goldfields due to Covid-19 <p>COVID-19 Protocols & Procedures will be observed at this event</p> <ul style="list-style-type: none"> • A maximum of 2000 people will be allowed at the venue at any one time if held outdoors, or 750 attendees if held indoors. • All persons attending this event must wear a reusable cloth or sponge face mask, or a disposable surgical mask, except when running while handling a dog in competition. Face shields only are not legal. Any person not wearing a mask will be requested to leave the venue. • All attendees must observe social distancing and, whenever feasible, maintain a distance of at least 1.5 metres between themselves and others with whom they don’t cohabit. • Sanitiser will be available at the Organisers’ Office, on all Judges’ tables, at ring entrances and in the toilet areas. <p>Please note that by entering and/or attending this event, participants are agreeing to comply with any instructions issued by the COVID-19 Compliance Officers, and that the organisers have the right to request any person who refuses to comply with a request or instruction to leave the venue.
