ONLY the latest official KUSA show entry form dated 01.01.2019 may be used. Kindly UPDATE your dog's details on the entry form. E mail explanations are not acceptable.

ONLY members of the KUSA shall be entitled to enter dogs in their registered ownership in any Championship dog show licensed by the KUSA.

The committee reserves the right to appoint alternative judge/s if necessary.

All exhibitors / handlers are responsible for the control of their dogs at all time and shall be personally liable for any claims which may arise in respect of any injuries or be caused by their dogs.

All dogs must be kept on leads at ALL times.

Bitches in season are allowed but due consideration by handlers to consider other dogs in the ring and surrounds.

The mating of bitches within the precincts of the show is forbidden.

Conditions attracting immediate disqualification are set out in Regulations 7 and 31 of Schedule 3 of the KUSA Constitution.

Puppies are not eligible for exhibition NOR are allowed on the grounds or the precincts of the show.
