Finals Judging Order:

Best of Breed, Reserve Best of Breed followed by Best Puppy, Best Junior, Best SA Bred, Best Veteran followed by Baby Puppy Classes and Neuter Dog Class

Challenges:

Grand Veteran; Breeders; Brace; Sire, Dam & Progeny; Neutered Dog and Field Trial (for dogs which have a Field Qualifying Certificate, a place in a KUSA Retriever Field Trial, or SAHR points - copy of Certificate to be submitted with entry).

Handlers:

Child Handlers (8 - 11 yrs); Junior Handlers (11 - 18 yrs)

Special Instructions and Notices:

- A dog is not eligible for entry in variety classes unless also entered and exhibited in a breed class.
- Only the latest official KUSA show entry form may be used (See KUSA Website)
- Only entries received simultaneously with proof of payment with the correct fees will be
 accepted. The Show Secretary will acknowledge receipt of entry via e-mail or SMS. If you
 do not receive this acknowledgment within 48 hours of submission of your show entries,
 please follow up with the Show Secretary.
- Bitches in season are permitted
- The mating of bitches within the precincts of the Show is forbidden
- Puppies under four (4) months are not eligible for exhibition
- Conditions attracting immediate disqualification are set out in Regulations 7 & 31 of Schedule 3.
- The Show Committee has the right to cancel or amalgamate classes, amend the prize list or to return entries or replace the Judge should the need arise.
- Covid Protocols: Subject to required Kusa Regulations and is subject to change.
 - o Access to this event will be through the top field gate. An Access Control Point will be set up at the gate, which will be manned for the entire duration of the event.
 - On arrival at the Access Control Point, all attendees will be required to be wearing a mask; have their temperature taken; and hand in a completed and signed Disclaimer form, after which they will be allowed access to the venue.
